AN ORDINANCE TO ASSIGN NAMES TO TOWN ROADS

Whereas Sec. 81.01(11) Wis. Stats. requires town boards to “by ordinance, assign a name to each of the roads in the town under town board jurisdiction ...”

Now therefore, the Town Board of LaGrange adopts this ordinance:

Section 1. Assignment of road names. The Town Board assigns the following names to town roads within the Town of LaGrange:

1st Avenue, 2nd Avenue, Asta Drive, Bay Drive, Bay Point Drive, Bay Shore Drive, Baywood Drive, Big Spring Road, Blackfoot Circle, Bluff Road, Bubbling Springs Road, Cali Drive, Cardinal Drive, Clover Lane, Connelly Road, Cool Hill Court, Cool Hill Drive, Country Club Drive, Court Lane, Duffin Road, Dunbar Drive, Eagle Drive, Farm Village Lane, Forest Road, Greening Road, Green Lake Drive, Hawk Road, Hill View Road, Jackson Road, Jason Road, Joni Lane, Katy Court, Kettle Moraine Drive, LaGrange Drive,

Lauderdale Drive, Lee Ann Lane, Lost Nation Drive, Mallard Drive, Mariner Hills Circle, Mariner Hills Court, Mariner Hills Lane, Mariner Hills Trail, McCabe Road, Meadow Lark Drive (N numbers), Meadow Lane, Nelson Road, Nine Indian Trail, North Drive, Oak Lane, Oak Park Road, Oakwood Drive, Pebble Beach Drive, Penny Lane, Peterson Road, Phillip Court, Plantation Road, Pleasant Hill Lane, Pleasant Lake Road, Pleasant Point Circle, Rendell Drive, Rice Road, Ridge Road, River Lane, Robinson Drive, Sherwood Forest Road, Surfwood Drive, Solid Comfort Drive, Sterlingworth Drive, Sterlingworth Court, Stewart Drive, Sweno Road, Tamarack Road, Territorial Road, Upper Oakwood Drive, Vicki Terrace, West Shore Drive, Woodland Court, Woodland Lane, Woods Lane, Yorkshire Court, Young Road

Section 2. Use of road names. No person may use any name not listed in this, or a revised version of this Ordinance.

Section 3. Severability. If any part of this ordinance is determined by a court to be invalid, the remainder is intended to be valid and continue in full force and effect.
