
ORDINANCE NO. 2016-02

**AN ORDINANCE TO CREATE SECTION IX(I) ENTITLED
"TETHER TOWABLES WITHIN THE SLOW NO WAKE AREAS,"
TO BE INCORPORATED WITHIN ORDINANCE NO. 2008-02 ENTITLED
"AN ORDINANCE TO REGULATE WATER TRAFFIC, BOATING
AND WATER SPORTS UPON THE WATERS OF LAUDERDALE
LAKES, WALWORTH COUNTY, WISCONSIN"**

WHEREAS, the Town of LaGrange and the Town of Sugar Creek have jurisdiction over Lauderdale Lakes, as they constitute 100 percent of the towns, villages and cities having shoreline of the Lauderdale Lakes chain of lakes, including Green Lake, Middle Lake, Mill Lake, and Don Jean Bay; and

WHEREAS, this ordinance is adopted pursuant to Wisconsin Statutes Sections 30.77(3)(ac)(1); and

WHEREAS, pursuant to Wisconsin Statutes Section 30.77(3)(d), the Town Clerk has submitted this ordinance to the Department of Natural Resources for review, at least 60 days prior to the Town of LaGrange taking final action in the matter; and

WHEREAS, the Town Board of the Town of LaGrange, Walworth County, Wisconsin, hereby finds that the following regulations are necessary and appropriate in the interests of public health, safety or welfare, including the public's interest in preserving the State's natural resources.

NOW, THEREFORE, the Town Board of the Town of LaGrange, Walworth County, Wisconsin, **DO HEREBY ORDAIN AS FOLLOWS:**

SECTION I. Town of LaGrange Ordinance No. 2008-02 entitled “An Ordinance to Regulate Water Traffic, Boating and Water Sports Upon the Waters of Lauderdale Lakes, Walworth County, Wisconsin,” Section IX entitled “Waterskiing & Other Towables,” subsection I entitled “Tether Towables within the Slow No Wake Areas,” is hereby created and incorporated into said Ordinance No. 2008-02 as follows:

- I. Tether Towables within certain Slow No Wake Areas. Towing is prohibited within the Lauderdale Lakes chain of Lakes in channels marked Slow No Wake between Green Lake and Middle Lake, and between Mill Lake and Sterlingworth Bay. All towables, including, but not limited to, tubes, ski ropes with or without skiers, or any other item that might otherwise be pulled behind the boat must be brought onboard and/or tethered directly to the boat and must be unoccupied while within the slow no wake zone.

SECTION 2: Severability.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict. Except for the addition to Ordinance No. 2008-02 that is accomplished by this ordinance, all terms and conditions of Ordinance No. 2008-02 remain unchanged and in effect.

SECTION 3: Effective Date.

This ordinance shall take effect immediately upon the Town of Sugar Creek adopting an identical ordinance, following passage and posting or publication as provided by law.






